In lieu of an annual cost of living adjustment, all full-time town employees, including the Mayor, shall have their salaries increased $\frac{4\%}{6}$ effective January 1, 2024. Each year, the Council will determine an annual adjustment at a Public Meeting before December 31st of the preceding year, to be effective as of January 1st of each subsequent year.

Section 2: All ordinances or parts of ordinances in conflict herewith be and are repealed.

<u>Section 3</u>: If any provision or item of this ordinance or the application thereof is held invalid, such invalidity shall not affect the other provisions, items, or application of this ordinance which can be given effect without the invalid provisions, items, or application, and to this end, the provisions of this ordinance are hereby declared severable.

Section 4: This ordinance be and is hereby made effective January 1, 2024.
