MOTION FOR APPROVAL

1. Motion by Alderwoman Poteet, seconded by Alderwoman Bishop to approve Resolution # 618-2011 authorizing the mayor to sign a grant agreement between The Rapides Foundation and the Town of Ball.

WHEREAS, the Town of Ball wishes to avail itself of a grant which has been offered to it by the Rapides Foundation, a Louisiana non-profit corporation, specifically for improvements of the walking trail and playground located near the Town Hall; and

WHEREAS, the purpose of the grant is to promote healthy behavior by creating and improving opportunities for adults and youth in Central Louisiana to engage in safe, accessible activity and with the objective of improving the existing walking trail and to add additionally playground equipment; and

WHEREAS, the Town of Ball will also develop and submit for approval a project budget with grant funding from the foundation not to exceed TWENTY-FIVE THOUSAND AND NO/100 (\$25,000.00) DOLLARS with the grant period being twelve (12) months beginning on November 1, 2011; and

WHEREAS, it is understood that the grant payment schedule shall be TWELVE THOUSAND FIVE HUNDRED AND NO/100 (\$12,500.00) DOLLARS due upon execution of the grant agreement in compliance with all funding conditions and TWELVE THOUSAND FIVE HUNDRED AND NO/100 (\$12,500.00) DOLLARS scheduled to be due on February 1, 2012 with an interim report due on April 1, 2012, and a final report on or before November 30, 2012; and

WHEREAS, the Town of Ball desires to authorize acceptance of general and reasonable conditions for administration, payments and the use of grant funds, budget, accounting and audit reports, access to and use of project information, and under the terms of the Grantor's reversion and termination, limitation, hold harmless, and special conditions; and

BE IT THEREFORE RESOLVED, that the Town of Ball hereby authorizes Mayor Jonathan Dean to enter into a grant agreement within the parameters set forth hereinabove for the purpose of memorializing the conditions, terms of acceptance and implementation of a grant from the Rapides Foundation for the purpose of improving the walking trail and playground near Town Hall.
